I **AGREE** in consideration for my participation in this APPLEATCHEE SUMMER 1 DAY DUAL OPEN SHOW 2008 (hereinafter called "Competition") to the following: I **AGREE** that I choose to participate voluntarily in the Competition with my horse, as a rider, driver, handler, lessee, owners, agent, coach, trainer, or as a parent or guardian of a junior exhibitor. I am fully aware and acknowledge that horse sports and the Competition involve inherent risks of accident, loss and serious bodily injury including, but not limited to, broken bones, head injuries, trauma, pain, suffering or death ("Harm"). I **AGREE** to release Washington State Horsemen and Appleatchee Riders Inc from all claims for money damages or otherwise for Harm to me or my horse and for any Harm caused by me or my horse to others, even if the Harm resulted, directly or indirectly, from negligence of Washington State Horsemen or Appleatchee Riders Inc. I **AGREE** to expressly assume all risks of Harm to me or my horse, including Harm resulting from the negligence of Washington State Horsemen and the Competition. I **AGREE** TO INDEMNIFY (that is, to pay any losses, damages, or costs incurred by) Washington State Horsemen and the Competition and to hold them harmless with respect to claims for Harm to me or my horse, and for claims made by others for any Harm caused by me or my horse at the Competition.

I have read the Washington State Horsemen Rules about protective equipment, and I understand that I am entitled to wear protective equipment without penalty, and I acknowledge that Washington State Horsemen strongly encourages me to do so while WARNING that protective equipment cannot guard against all injuries.

If I am a parent or guardian of a junior exhibitor, I consent to the child's participation and **AGREE** to all of the above provisions and **AGREE** to assume all of the obligations of this Release on the child's behalf. I **AGREE** that Washington State Horsemen and "Competition" as used above includes all of their officials, officers, directors, employees, agents, personnel, volunteers and affiliated organizations. The Construction or application of WSH rules is governed by the laws of the State of Washington (RCW 4.4).
