Camping/RV: *Power/Water \$35* per night per unit. *Dry Camping at \$20* per night in designated areas. Spaces are available after 3:00 PM Friday.

Closing date of entries: Friday, June 30, 2023, unless the show becomes over- subscribed, in which case entries will be limited and will be accepted as received. Telephone entries will not be accepted.

Post Entries: Management reserves the right to accept post entries if space allows. Post entries include any entries posted after June 30th and before July 5th. There will be a post entry fee of **\$10.00** per class.

<u>Refunds:</u>

A) Refunds will be made if entries are withdrawn **BEFORE CLOSING** date less \$20 Office fee.

B) Refunds **AFTER CLOSING DATE** *allowed* only upon presentation of a veterinarian's or doctors certificate. Otherwise, no refunds of entries or stabling after closing date unless there is a waiting list for the stall/ride and the space <u>can be filled</u> from a waiting list at least 3 days prior to day of competition.

B) A \$20 Office fee <u>will be deducted</u> from all refunds made after the closing date.

Show Office: Located inside the Indoor Arena. Open one hour prior to first class and will close one-half hour after the last class.

Barn chart: will be posted at the office and stalls will be marked.

Services:

Concessions on the grounds during show hours.

First Aid assistance is available on grounds. Hospital/Clinic within 10 minutes of the grounds. **Veterinarian and Farriers numbers** will be posted in show office

Classes

Ride Times: A ride schedule will be emailed **to each rider** after the closing date. Ride Times will also be posted **Friday**, **July 7th by 7PM.** If ride times are not received, it is the responsibility of the rider/owner to contact Show Management. Any changes in Time Schedule will be posted outside the **SHOW OFFICE**. Tentative start times will be **8am each day**.

Combination of Classes: The show management reserves the right to cancel or combine (where less than three horses are entered), or divide classes, or change order for award purposes.

Competition Tests:

All Classic Dressage will be the 2023 USDF tests. Eventing dressage tests will be the 2022 USEA tests. Western tests will be the 2022 WDAA tests. In Hand tests will be 2023 USDF tests.

Test of Choice Classes: There will be no changes to Test of Choice classes after the entry closing date.

Arena: All tests will be ridden indoors on dirt/sand footing. USEF, WDAA Intro and Basic, and USDF Intro & Training will use a 20M X 40M arena, otherwise, Training and all other classes will use a 20M X 60M arena.

There is a covered warm up arena and one additional outdoor arena may be available for warm up and lunging. The covered Warm-up will be limited to 5 riders at a time. No foot traffic is allowed in the warm up arena other than show officials, In-Hand competitors, and Lead Line handlers. NO LUNGING will be allowed in the covered warm-up arena during show hours.

Judge's decision in all classes is final. No one shall approach a Judge regarding a decision unless they first obtain permission from the Show Secretary who will arrange an appointment at a proper place and time.

Accuracy of Scores: It is the responsibility of the competitor to verify the accuracy of scores. Any scoring errors must be reported to the Show Secretary and/or the assistant within two hours of the last ridden test for that class. Failure to report any errors within the time allowed will mean that the error will not be corrected and there will be no change in class placing.

RIDERS MUST BE PRE-ENTERED TO BE ELIGIBLE FOR HIGH PT. AWARDS.

- Youth Rider: 21 and under as of January 1st, 2023
- Adult Amateurs must present valid WSH, USEF or WDAA Amateur cards with entry. All other Adults will be considered Open competitors.
- The High Test Score award will be given to the English and Western riders with the highest scoring test of the recognized portion of the show.

Awards: Ribbons to five places for all non-schooling classes.

DIRECTIONS:

From West: US 2, enter on Wenatchee Ave., right on Miller St. to the very end of the road, right on Circle St, right onto Appleatchee grounds.

From East (Quincy): From the George Sellar Bridge, take the Malaga/Alcoa HWY exit, go Right on Ferry St, then use the left hand turn lane to go Right on Wenatchee Ave. Take a right on Crawford St., left on Miller St, to end, right on Circle St, right onto Appleatchee grounds. **Your GPS will likely take you a slightly different route. This route avoids a corner that is difficult for*

most trailers.

APPLEATCHEE GROUND RULES MUST BE OBSERVED. Rules are posted on the grounds at various locations and available on our website.

DOGS: Dogs on the show grounds must be controlled on a leash, confined to vehicles, or crated, always. No Dogs other than service animals are allowed in the arenas. A 'donation' of \$50.00 will be required to free an impounded canine. If the owner of a loose dog cannot be found, the dog will be turned over to the Humane Society.

STALLIONS: No stallions over the age of 18 months may be stabled or ridden on the grounds except during sponsored events and must be managed by an Adult 18y.o. or over. No Youth Competitor may show a stallion.

CONDUCT: Show Management reserves the right to refuse any entry of an exhibitor or the participation of any agent, trainer or rider who has demonstrated unsportsmanlike behavior at a Appleatchee Show or to its Management.

The Appleatchee Riders Dressage Show is operated in accordance with the current rules of WASHINGTON STATE HORSEMEN - Horse Show Division of which it is a "B" System Show and in accordance with the current rules of the Western Dressage Association of America. This show is sponsored by the Appleatchee Riders Association Performance Division.
